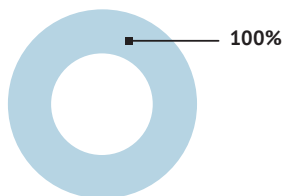

INFRASTRUCTURE

All schools in the Czech Republic have electricity, piped water, clean water and flush toilets. Most of the toilets were gender private. Most of the schools have dedicated eating spaces/cafeterias and kitchens. School meals were prepared on-site (on school grounds), off-site in centralized (not private) kitchens and off-site in private facilities (caterers).

SPECIAL NOTES

During the 193 school days, children in the primary and secondary schools are provided in-school meals daily. Education in the Czech Republic is compulsory. The programs have universal target. The estimated cost per student per year is 3088-6176 CZK (136-272 USD).

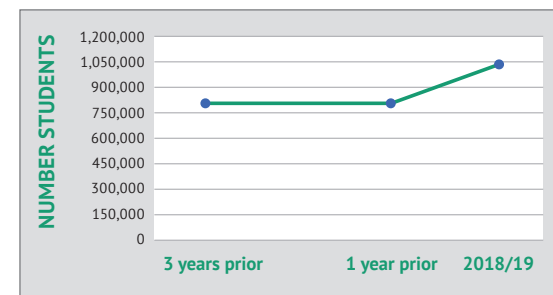

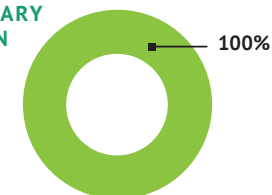


COVERAGE: PRIMARY AND SECONDARY SCHOOL-AGE CHILDREN
