

Rather, school snacks are organized by the schools themselves. Other initiatives related to healthy eating in schools are organized by the federal states of Austria, and the Ministry of Health harmonizes the various programs in this field.



SUCCESSES AND CHALLENGES

Among the successes related to school feeding in Austria, parents report that students' awareness of healthy dietary practices and agricultural production has increased, and school staff estimate that the scheme led to an increase in students' consumption of fruit, vegetables, and milk. As consumption behavior is difficult to change, a challenge remains that students prefer sweetened cocoa to dairy milk.
